The minutes were unanimously approved as an accurate record and were signed by Cllr Hall.


38. Consideration of planning applications

- a. 24/01479/OUT New dwelling and associated access Land To The East Of Gamage Close Balderton - This application was unanimously objected to due to overshadowing/loss of outlook, noise levels, right of access and previous flooding in the area.
- b. <u>24/01606/ADV</u> Replacement signage to entrances and branding to buildings Saint Gobain Formula, Jericho Works, Bowbridge Lane, Balderton Item to be deferred to Full Council meeting on October 23rd as 1 councillor had declared an interest in this application leaving only 2 councillors (no quorum).
- c. 24/01672/RMAM Reserved matters application relating to appearance, landscaping, layout and scale for 430 dwellings with associated wider infrastructure Land at Fernwood South Claypole Lane Fernwood This application was unanimously objected to due to density of housing, lack of green spaces, lack of parking, noise, knock on effects for Balderton from the highways issues that this development could cause during construction and after.
- d. <u>24/01716/HOUSE</u> Erection of a new front porch 8 Grove Street, Balderton NG24 3AZ This
 application was unanimously supported.

PUBLIC NOTICE

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State gives notice of the proposal to make an Order under section 247 of the above Act to authorise the stopping up and diversion of a length Kennedy Walk at Balderton in the District of Newark and Sherwood.

If made, the Order would authorise the stopping up only to enable development as permitted by Newark and Sherwood District Council, under reference 22/00892/FUL.
